# 9.0 Report from A85 Workshop Notes – Tim Grace

ACODE 85 – Summary Report for Business Meeting (12 November 2021) "Making the complex accessible with smart solutions"

The ACODE 85 Workshop objectives were to:

- bring universities together to stimulate a robust exchange of thought on a common theme the interpretation of Learning Spaces.
  - 103 registrations (representing 27 universities across Australasia)

- the day's average attendance was around 70; its peak was more like 80; by end of day it had dropped to about 50.

- the Zoom chat function was active throughout the day and helped to gage the mood and guide the discussion

- feedback (so far) has been very positive.

- raise interest in Learning Spaces as a meaningful topic in the context of TEL.
   carving out a space for ACODE to speak authoritatively in its area of knowledge and expertise is important is there risk that we might be outstretching our domain of interests?
   Learning Spaces is a broad topic that crosses over many areas of campus activity are we just contributing to campus planning; education design; and space/time usage?
- locate areas of activity in the construction and/or refurbishment of Learning Spaces.
   mapping out the lay of the land is a useful activity there's an ever growing wealth of local knowledge that needs to be tapped to create an Australasia wide picture
- canvass the subject area to explore current trends and possible directions.
   tapping into local activity to identify current and common themes is a useful strategy refurbishment, timetabling, body-counting,
- reflect on the use of HyFlex solutions in delivering to, and engaging with, a diverse and dislocated student cohort

   new possibilities and innovations meeting changed environments Hybrid and Flexible solutions convergence and emergence in action (reappropriation of existing resources)
- showcase some examples of recent activities that offer opportunities for others to explore and expand the scope of Learning Spaces (as they relate to TEL).
   we didn't get any engagement from other universities so this session was very ANU-centric but the point was made that with the larger Learning Spaces arena there's lots for others to do.
   we missed an opportunity in not eking-out more information from the likes of Luke Boulton there's so much happening TEL related activity happening within Learning Spaces
- interact with other like-minded associations opening minds to partnerships (e.g. TELedvisors and Learning Environments Australasia)

- LEA: Ella Masters - I just wanted to say thanks again for having me along yesterday – I really enjoyed the content and thought people were quite receptive to my piece about LEA. If you wouldn't mind passing my details onto Michael that would be great. Let him know that we would be happy to talk about any value we might be able to bring in the development and review of ACODE's benchmarks.

## 16.0 Liaison with other Organisations

**CAUDIT** – Greg Swayer has been appointed Interim CEO to CAUDIT apart from the THETA meetings there is nothing else on there aganda at the moment.

**Ako Aotearoa** – The focus for AKO seems to be movinh away from Higher Ed institutions and more towards the private institutions in New Zealand. It may be of more interest for ACODE to engage with FLANZ.

## ACTION:Karen and Michael to look into an MOU with FLANZ.

**TEQSA** - very little contact with TEQSA they too seems t their approach also seems to be changing to res[o be more focused on private providers and Academic Integrity.Ptere Cpldrake is the new CEO and has a different flavour to Tony and they also have new Commissioners,the approach is changing and responding to issues in the sector at present.They are dping more spot audits rather than the full on audits that were very cumbersome. ACODE is still referenced by TEQSA.

**ICDE-**No contact unlike last year.

# 17.0. HOT TOPICS:

TEQSA are preparing a blacklist of sites that students use for cheating, such as Chegg. Do you know anything about it and how it is intended to be used in Australian unis? Suggestion here that IT implement blocking for these sites but can't see how that would work when everyone taking tests from home!

Nigel Robertson University of Waikato posed the above hot topic, as he states the list of Teqsa blacklist sites that students use for cheatinf could be thousands of sites, and as exams are take home at the moment home computers cannot be blocked Is there a solution.

**Adelaide:** blocked 3000 sites then had to unblock as Academics could not do integrity checks.

Sites are not updated as this is a huge job, they would like to install some sort of redirect to student help sites approved by the Uni but so far have not achieved this. **Central Queensland Uni:** They blocked nut did not release as Academics working from home could not check from home; Some requeste for Chegg liscences but this was not supported

**Melbourne:** TEQSA did a good job on reporting this. Melb are not blocking any sites or redirecting as this is used to collect data on contract cheating. The University has also witnessed There is a sense of collusion rather than collaboration hence there is is change afoot in the way students are assessed. There is rarely a tech solution to human behaviour.

**Auckland**: Academics in each faculty have academic integrity advisors for both staff and students, There is Is a rethink on assessment items.

Sydney: Sydney has a strategy to reduce Exams and also use Inspera.

**Auckland:** Inspera creates a marking overload for academics- There is no PD available to staff for marking.

**Adelaide:** Inspera has no value for academics and has too much staff development required. Adelaide have had a big win in weaning people off paper to inclass digital exams

**Melbourne:** Gradescope has massive benefits from the LMS to Gradescope for marks. Melbourne are running an experimentover the summer using Chromebooks rather than a BYOD for exams. The Chrome books have access tolimited URL's.
