1.0 Welcome from President and President's Report - Michael Sankey

The President Welcomed all to the Business Meeting and commented on the very productive workshop yesterday which should produce a good report in due course.

The President also welcomed Sheila McCarthy back to the Executive.

Your Exec have already meet 3 times this year twice on line and a 3 day face to face meeting in Brisbane hosted by CQU, thankyou to Kate Ames for hosting. The Strategic Plan and Action Plan were updated for the next two years.

The Exec had decided to run ACODE 88, planning was also undertaken at this meeting. Gravitas was needed so a hybrid model was adapted.

Griffith are looking at hosting ACODE89 mid-year as a CAUDIT Cyber Security run event, more on that once plans are finalized.

The MOU with Ascilite has been completed and signed. This is a slightly different but much stronger MOU.

We have agreed that:

- The Exec of both organization's will meet at least once a year
- ACODE will still continue to present the TEL awards at the Ascilite conference
- We endeavor to hold other joint events

An MOU with CAUDIT was signed late last year with ACODE and CAUL now receiving a profit share from THETA and there will also be a presentation given at THETA on the outcome of A88.

STRAGEGIC PLAN & ACTION PLAN: not a lot of change to the Strategic plan but the Action plan was updated.

We will have upcoming projects that we will be calling for volunteers to help with some of these. These include:

- Building Capacity in TEL and our Workshops.

We are hoping to go back to face to face meetings mid-year but will also present these as Hybrid as well.

Overall, the sessions ran well, and the facilitators did a good job. This has given a deep dive into the conversations.

There was a clear emphasis on the stress on Academic Integrity. Strong Leadership also came out as an essential element. There also needs to be a clear accountability on managing up.

A primary concern was a commitment in using the tools we may not be able to use in the future. They are free now but for how long.

Its tactics not tools that will be essential, to the accrediting bodies.

Paul Denny's presentation was useful quoting that students want examples and that they do not care where these examples come from, so use the tools we have available now.

Academics are concerned that they may be replaced, hence its better to converse with academics re: enabling AI for both staff and students.

There were huge conversation re Senior Leadership, and the need to manage up. Outcomes shape the Institutional response.

All in all a very successful Exec run workshop, many hands made light work.

We should consider more cross institutional collaboration in the future following the success of A87 and A88 as the Exec are spread across various Institutions.
