FROM THE PRESIDENT

2013 has been another busy and productive year for the Council, as we have: organised and run 3 workshops and business and networking meetings (1 offshore and 1 joint with the Council of Australian Directors of Academic Development units); continued work on our Office for Learning and Teaching National Networking Initiative Project; and successfully run our biennial intensive Learning Technologies Leadership Institute.

As ever, the strength of ACODE is in its workshops and business and networking activities, which are attended by institutional representatives from Australia, New Zealand and the South Pacific. These meetings facilitate the exchange of information, allow members to get updated on the latest educational trends and seed sector-wide projects.

As a Council we have a responsibility to provide leadership to the sector in technology enhanced learning.

The University of the South Pacific (USP), for the first time, hosted an ACODE workshop and business and networking meeting in June at the University's Laucala Campus in Suva, through its Centre for Flexible Learning (CFL).

At the opening of the workshop, Vice-Chancellor and President of USP, Professor Rajesh Chandra, warmly welcomed the representatives of ACODE to the University and shared with them the emphasis USP places on incorporating OER, Distance and eLearning methods into its

curricula. Professor Chandra commented that the workshop on Flipped Classrooms and Open Education Practice "... will be very helpful, especially for our students in our regional campuses" (source: http://www.usp.ac.fj/news/story.php?id=1298).

Providing our members with access to information on the latest trends is crucial. Our Office for Learning and Teaching (OLT) funded National Networking Initiative Project was launched in November, just prior to our second joint workshop with CADAD on exploring student voice in online education.

ACODE LEARNING TECHNOLOGIES LEADERSHIP INSTITUTE 2013

The ACODE Learning Technologies Leadership Institute was held at Twin Towns Resort in Coolangatta on the Gold Coast between August 18th - 22nd. Thirty participants were registered and attended representing 19 different institutions. The institutions included 12 Australian Universities, the University of the South Pacific, a New Zealand University, a New Zealand Polytechnic, the Australian Bureau of Meteorology, and Open Universities Australia. There were three further participants representing the three sponsors; the Office of Learning and Teaching, AARNet, and Desire 2 Learn.

The Institute's success hinges on the level of engagement each participant brings to their individual and group activities as they work through the 'Making the Case' scenario. The realism of the case and its relevance to the participant's academic and professional life is critical to the level of engagement. This year, it was decided that rather than present different scenarios to each group, only one scenario would be provided and all groups would address that scenario. To ensure realism, the scenario was circulated to participants prior to the Institute and they were invited to contribute to the various scenario elements to ensure it was current, reflective of the Australian Higher Education context and credible.

Their own contributions to the scenario structure was a significant factor in enhancing participant engagement in the 'Making the Case' deliberations. These contributions provided the nexus between the scenario and the 'real world'. This was important as the Institute participants came from a wide range of roles and a significant number were not in a position to clearly see the big picture within their own organisations. Nonetheless, the scenario meant that the groups had to address many of the 'real world' issues that impact on technology and leadership issues in their Institutions.

It was clear from observations, feedback from both Faculty and Participants, and the overall presentations, that the LTLI fully engaged all the participants and that it was a very successful, challenging and valuable event.

ACODE WORKSHOP SERIES 2013

Each year ACODE runs a series of Workshops and related activities on key topics relevant to higher education. These workshops provide a forum to explore implementation issues associated with new flexible and online learning initiatives and offer opportunities to review institutional resources, practices and policies. One of the substantial benefits is that staff from other universities share newly developed resources and ideas, which can be used in all institutions to save considerable development time. The workshops are rotated around Australia New Zealand and the South Pacific so that each university has the opportunity to send extra staff for professional development through attendance at the Workshops.

ACODE 61: LEARNING SPACES, THE UNIVERSITY OF SYDNEY, NSW, MARCH 2013

This workshop was concerned with defining and categorising learning spaces; Governance of learning spaces; Approaches to physical and virtual learning space integration; Professional development; and Evaluating learning spaces (evidence of impact, teacher transformation).

Learning and teaching spaces are in a constant state of flux and this workshop looked at how to redefine the space that was available in each institution. A forum was provided for attendees to debate the definition of space and how better we may teach and use the space available to us all. More importantly what technologies the spaces need to have to better enable the learning experiences of the students.

Colin Lowe from the University of Sydney organised and led the workshop involving 35 attendees from 19 institutions.

An opening address by Professor Rob Ellis and a keynote address from Kathleen Donohue opened the event. Presentations were well received from Mark Northover (Auckland University of Technology), Lisa Germany (Victoria University), Regina Obexer (Queensland University of Technology), Danny Munnerley (University of Canberra) and Trish Andrews (University of Queensland).



ACODE 62: FLIPPED CLASSROOMS AND OPEN EDUCATION PRACTICE, THE UNIVERSITY OF THE SOUTH PACIFIC, SUVA, JUNE 2013

The experience for ACODE 62 was unique as the workshop itself was flipped, with resources and activities being provided prior to the event itself in Suva. The other first for ACODE was that this workshop was streamed live back to Australia and we have to thank the team at AARNet for helping to facilitate this. The streaming was well received by those in Australia that participated.

Theresa Koroivualono from the University of the South Pacific organised and led the workshop involving 44 attendees from 13 institutions.

This was the University of the South Pacific's (USP) first experience hosting an ACODE workshop. They used the opportunity for the professional development of many of their teaching and professional staff, including developing the organisational skills of their administrative staff who assisted with the logistics of hosting this international event.

ACODE were warmly welcomed by Vice Chancellor and President of USP Professor Rajeesh Chandra followed by a traditional Fiji welcome accepted by President Helen Carter.

Presentations were from Dr Ledua Waqailiti and Evan Naqiolevu (USP), Helen Carter and Andrew Burrell (Macquarie University), Michael Sankey (University of Southern Queensland), Gerry Kregor and Luke Padgett (University of Tasmania), Danny Munnerley and Matt Bacon, ARstudio (University of Canberra). The day concluded with a tour of the campus and a demonstration of REACT (a distance teaching tool) with the Vanuatu and Tonga campuses.

ACODE 63: EXPLORING THE STUDENT VOICE IN ONLINE EDUCATION, THE UNIVERSITY OF QUEENSLAND, QLD, NOVEMBER 2013

ACODE 63 was the second time that ACODE has organised a joint Workshop with the Council of Australian Directors of Academic Development (CADAD).

Trish Andrews from the University of Queensland with support from Helen Carter from Macquarie University led and organised the Workshop involving 43 ACODE attendees from 26 institutions including 20 CADAD members.

This workshop was concerned with more consideration of the student voice in their learning experience to provide benefits not only to students but also to institutions. This workshop explored the student voice in online learning environments.

Belinda Tynan, PVC teaching and learning at the Open University, UK, was the main presenter, providing insights into student experience at the Open University. Trish Andrews and Belinda Tynan also presented on an OLT project 'Exploring the Online Learner's Experience with ICT for Learning and Teaching".

Mitch Parsell (Macquarie University) engaged us with his Online Standards project, Karen Nelson, Director, Student Success and Retention, Queensland University of Technology presented on Student engagement: what we know and the implications for academic literacies. Gerry Kregor, University of Tasmania, provided his reflections on quality and led a group discussion with all presenters, as well as Denise Chalmers (Acting President of CADAD) to end the Workshop. A tour of the Advanced Engineering Building at UQ concluded the day.
